SECTION V **HEALTH HAZARD DATA**

SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

FIRST AID MEASURES

EYE CONTACT : IMMEDIATELY AND IMPERATIVELY FLUSH EYES WITH LOTS OF RUNNING WATER FOR AT LEAST 15 MINUTES. PROMPT MEDICAL ATTENTION IS ESSENTIAL.

INHALATION : REMOVE TO FRESH AREA. IF NOT BREATHING, GIVE MOUTH TO MOUTH RESUSCITATION. IF BREATHING IS DIFFICULT, ADMINISTER OXYGEN. CALL A PHYSICIAN.

INGESTION : DO NOT INDUCE VOMITING. DRINK LARGE QUANTITIES OF WATER AND TRANSPORT VICTIM TO MEDICAL FACILITY IMMEDIATELY. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.

SKIN CONTACT : WASH SKIN WITH LOTS OF SOAP AND WATER. REMOVE CONTAMINATED CLOTHING AND SHOES; WASH BEFORE REUSE. IF IRRITATION OCCURS AND PERSISTS SEEK MEDICAL ATTENTION.

SECTION VI**REACTIVITY DATA**

STABILITY: STABLE

INCOMPATIBILITY (MATERIALS TO AVOID): AVOID CONTACT WITH MOST METALS, STRONG ALKALIES OR OXIDIZERS.
