SKIN CONTACT : CAN CAUSE IRRITATION TO SKIN UPON CONTACT WITH POWDER. CONTACTING WITH CONCENTRATED SOLUTION WILL CAUSE IMMEDIATE LOCAL REACTION INCLUDING ITCHING, IRRITATION, FOLLOWED BY LOSS OF SURFACE LAYERS OF SKINS.

**FIRST AID MEASURES**

EYE CONTACT : IMMEDIATELY FLUSH EYES WITH LOTS OF RUNNING WATER FOR 15 MINUTES, LIFTING THE UPPER AND LOWER EYELIDS TO ENSURE FLUSHING OF THE ENTIRE SURFACE. SEEK MEDICAL ATTENTION AS NEEDED.

INHALATION : REMOVE TO FRESH AREA. IF BREATHING IS DIFFICULT, ADMINISTER OXYGEN. IF BREATHING STOP, START ARTIFICIAL RESUSCITATION. TRANSPORT VICTIM TO A MEDICAL FACILITY IMMEDIATELY.

INGESTION : DO NOT INDUCE VOMITING. DRINK LARGE QUANTITIES OF WATER AND SEEK MEDICAL ATTENTION IMMEDIATELY. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.

SKIN CONTACT : WASH SKIN WITH LOTS OF SOAP AND WATER. REMOVE CONTAMINATED CLOTHING AND SHOES; WASH BEFORE REUSE. IF IRRITATION OCCURS AND PERSISTS SEEK MEDICAL ATTENTION AS NEEDED.
